Youth programs are going well, we had two OSAD days this month and both were full and had a waiting list. Connor secured a \$1500 sponsorship for the summer movies. He is hoping to get a few more. If not, \$1500 pays for half of the series. April 1^{st,} we start summer camp sign-ups for BSL residents. April 2nd will be open for non-residents. Revenue for February was \$10,649.53. We are under \$5,000 for money past due. We typically sit around \$8-9,000 for past due

accounts. Kayla is doing a great job getting folks to pay their past due amounts! Founders Day update – May 4^{th} is the rain date. We've been approved for a new storage shed. All new park signs that were ordered have been installed. Also added a 5 laps = 1 mile sign at Muse Park. Waiting for a few more signs that were missing.
